CORRECT COLOR USE

Primary brand colors should be used as the main colors in all documents, presentations, event collateral and all other branded pieces.

Secondary brand colors should be used as accents to the primary brand colors [infographics, graphs, subtitles and subheadings, call-out quotes and numbers, etc.].

COLOR GUIDE

CMYK

This color format is used when printing. [Ex. flyers, brochures, event banners, etc.]

RGB

This color format is used with digital files. [Ex. website, email, presentation, etc.]

All logo files have been saved out in both CMYK and RGB color formatting.



FONT

The Houston EB5 brand font is Montserrat.

Montserrat Black - headings and titles

Montserrat Medium | Semi-bold - subtitles and subheadings

Montserrat Regular - body copy

Montserrat Italic | **Medium Italic** - photo descriptions, legal text



PRIMARY LOGO

Primary logos should be used first and foremost on all marketing collateral as the initial introduction of the brand. This will create and establish brand recognition amongst our attorneys, investors and within our city to ensure continued growth.





SECONDARY LOGOS

Secondary logos should only be used in instances where the primary logo has already been introduced within the same document or the primary logo is not visible on the background of the document being created.

FILE USE GUIDE

EPS

EPS format is a vector file that can be opened by the widest range of software, this format may be requested by print or manufacturing companies.

JPEG

Jpeg's are most commonly seen online. This is because jpeg offers very good compression without overly degrading the image, meaning the file size is small and will load quickly.

PNG

Unlike Jpeg files, PNG format allows for transparency and can be placed over colored backgrounds or images.



LETTERHEAD

Letterhead should be used for all important memos, letters to potential investors, clients, attorneys and any correspondence with an outside entity that is not included in an email.



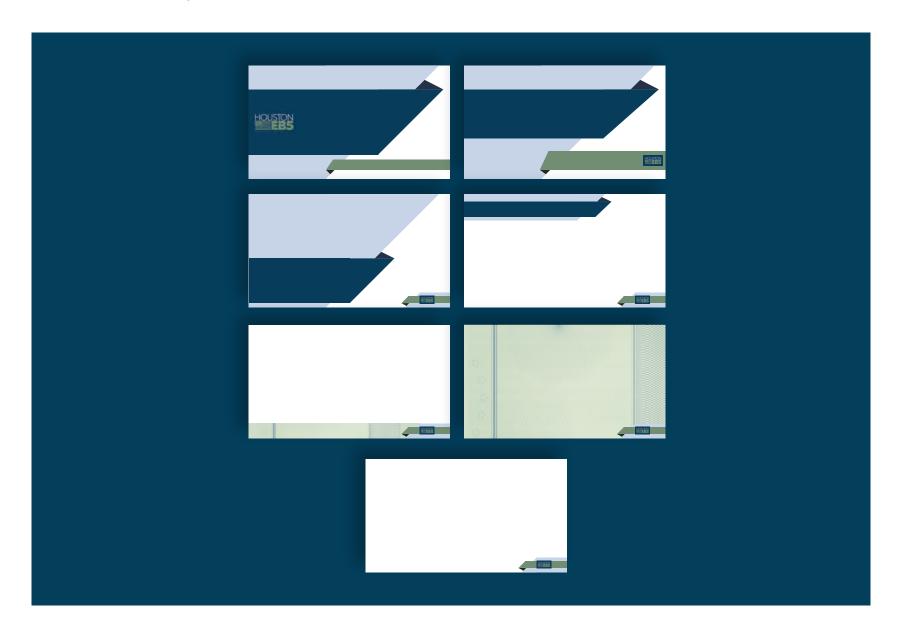






PRESENTATION

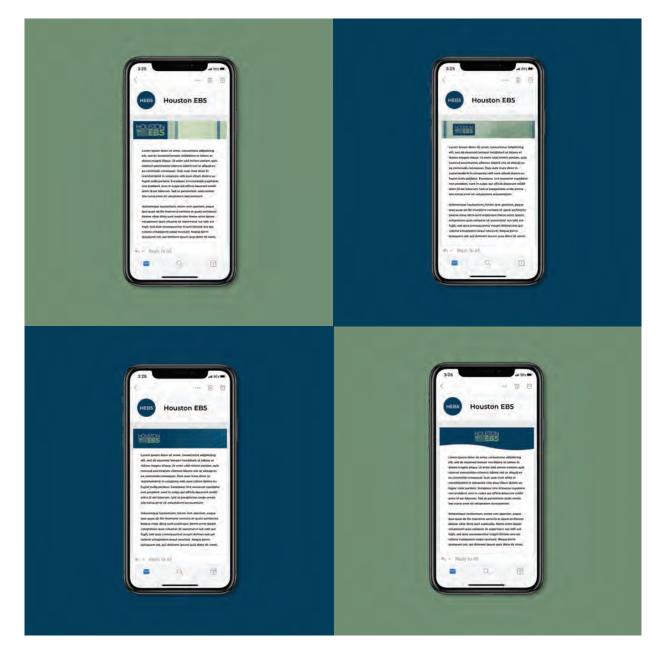

EMAIL TEMPLATES

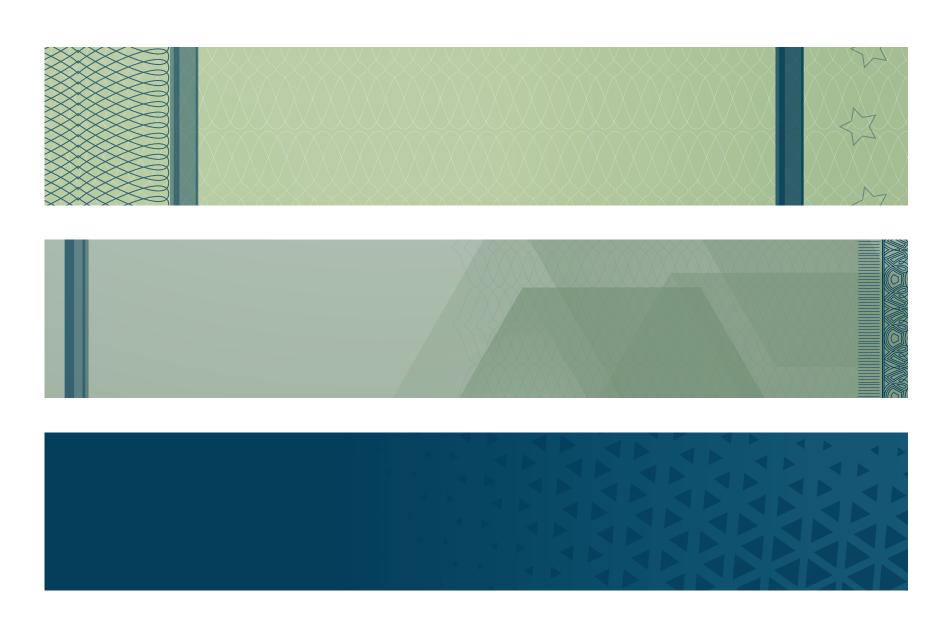
